

RESOLUTION 071223

WHEREAS, in compliance with Florida Statutes, at the meeting of the SANIBEL FIRE AND RESCUE DISTRICT, BOARD OF COMMISSIONERS held on JULY 12TH 2023, the following resolution is hereby adopted:

NOW, THEREFORE, BE IT RESOLVED, by the COMMISSIONERS OF THE SANIBEL FIRE AND RESCUE DISTRICT BOARD that the documents attached hereto, will be made part of this resolution, and indicates the following:

A RESOLUTION THUS, PROVIDING FOR THE DISTRICT'S BOARD TO ADOPT THE TENTATIVE MILLAGE FOR THE FISCAL YEAR 2023-2024, BY USING THE MILLAGE OF 1.8753 WHICH WOULD EXCEED THE ROLLED BACK RATE OF 1.1061 MILLS RESULTING IN A TAX PERCENTAGE INCREASE TO RESIDENTS OF THE DISTRICT OF 69.54%

ALSO INSTRUCTING THE DISTRICT'S ADMINISTRATION TO COMPLETE THE DR420 AND THE DR420-MMP AND SUBMIT THEM TO THE COUNTY WITH THE ESTABLISHED MILLAGE RATE OF 1.8753 AND SETTING THE HEARING DATE FOR SEPTEMBER 6TH 2023, AT 5:01 PM AND THE 2ND FINAL HEARING DATE FOR SEPTEMBER 20TH 2023 AT 5:01 PM.

WHEREAS, THE BOARD OF COMMISSIONERS OF THE SANIBEL FIRE AND RESCUE DISTRICT desire to adopt said policy in accordance with the current laws of the State of Florida.

A COPY OF ALL LEGAL FORMS AND LETTERS FOR THE SAID ITEMS IS ATTACHED HERETO AND A COPY WHICH IS ON FILE WITH THE FIRE CHIEF IS HEREBY APPROVED AND ADPOTED.

This procedure will commence JULY 12TH 2023.
